This 1 and 1/2 day course trains maintenance personnel in the proper procedures to visually inspect CNG fuel systems from high pressure cylinders through the 1st stage regulator. Covers cylinder identification, installation, General and Detailed Visual Inspections, proper venting (de-fueling), disposal and documentation. It is designed to raise the reliability of the industry and confidence of the general public in the safe handling and maintenance of high pressure natural gas storage systems.

Competence will be measured by lab demonstrations, written pre/post quizzes, in-class assignments and worksheets. Certification will be issued by CSA-America Inc., U.S. Operation. The course will conclude with a 3- hour test proctored off-site on Wednesday, for Class #1 and Friday for Class #2.
