  - How to define a large, small, very small agencies
  - Discussion about "resort" agencies

# November Meeting Summary (cont)

- Discussion about approach CDOT should take for FY18 if don't reach new policy in time
  - Equal reduction
  - Increase size of pot by taking from capital
  - Phase out 80/20 split

# In General...

- Simplicity is good, but Colorado has diverse transit systems
- A formula is a good tool, but
  - Some subjective assessment will be needed
- Some grouping of systems needs to continue but
  - There is not agreement on how to classify systems



# In General...continued

- Equity is important for CDOT, and Title VI considerations
- Stability in funding is important
- Factors identified for discussion:
  - Jurisdictions served
  - Local investment
  - Levels of service or measures of system size
  - Productivity and efficiency
  - System or network connectivity
  - Highway congestion / air quality
  - Trip purposes: commute and human service trips rank high

There is agreement on the top four. More discussion is needed on others.


# JURISDICTIONS SERVED AND LOCAL INVESTMENT

## **Jurisdictions Served**

- The number of jurisdictions served may be more useful than land area.
- Value of agencies serving multiple jurisdictions
  - Do they provide regional services, helping to connect rural residents to urban centers?
  - Do they consolidate grant applications and share transit management capacity?
  - Do they build local match and /or blend human services funds to match transit funds?




#### **Transit System Service Areas**





#### **Governance and Funding**






## **Local Match**

- P-N-Ps are popular for transit services
  - Can blend fund sources
  - Can serve across jurisdictional bounds
  - Do not have taxing authority
- Municipal and county operations often prefer non-dedicated taxes
  - Flexibility
  - Additional small cities have dedicated taxes such as Fraser and Sterling
  - Large system 5311 funding has been fairly stable



# Categories

- Using categories of systems can provide:
  - A means for smaller or poorer areas to get 50/50 funding for critical services (equity)
  - A means to address lack of 5311 funds
  - A framework so communities know what to expect
- What method of categorization is going to help achieve this?





Small	< 100,000 miles	12	<20,000	11
Medium	101,000 - 200,000	8	20,000 - 100,000	10
Large	200,000 - 999,000	10	100,000 - 1,000000	9
Very Large	> 1,000,000	4	>1,000,000	4

	Cost	Systems	Revenue Hours	Systems
Small	< 500,000	14	< 5,000	11
Medium	500,000 - 1,500,000	10	5,000 - 20,000	12
Large	1,500,000 - 5,000,000	7	20,000 - 50,000	10
Very Large	> 5,000,000	3	> 50,000	4

## Performance Standards

### Findings:

- Overall CO systems perform well
- May not be helpful in differentiating funding levels
- Agreement is needed on definitions
- Will still need to consider:
  - How much weight should be given to performance?
  - For systems with more than one mode, is it useful to consider performance of each mode?



### **DEVELOPING A FORMULA**



# CDOT's Perspective: Ideally

- Formula is:
  - Fair
  - Simple
  - Responsive to changes in grantees and service levels
  - Reviewed about every few years
- Formula provides stable funding
- Formula covers majority of funding, but some is allocated based on other factors

# Potential Ways to Build a Formula

### **Base Funding**

- Allocation based on size (small to very large) plus
- Allocations for items such as:
  - Jurisdictions served
  - Service connecting communities
  - Local investment
  - Efficiency & productivity
  - % workers commuting by transit or serving congested highways
- Address coordination efforts & financial need separately

### **Sliding Scale**

- Majority of funds allocated on size measure(s) such as budget, hours of service, or population served
  - Allocate funds based on sliding scale with small systems getting maximum and smaller amounts as system size increases
- Formula or subjective?
  - Coordination efforts, jurisdictions served, local investment, providing regional services, employment transportation
